#### 4) Superintendent's Report

Dr. Wood discussed the purchase of two cameras for the hybrid classes to help the students who are learning from home and those in the classroom. Once the cameras arrive they plan to set up a demonstration. Dr. Wood is hoping that the cost of the cameras will be covered under the Cares Act.

Our building officially opened July 1st, but the teachers have not been allowed in their

rooms as of yet pending a meeting to set up safety protocol.

Athletics have resumed as of Monday. Only outdoor practices are taking place at this time and extreme caution is being taken. Mr. Eubanks stated we have had higher attendance than usual and temperature checks are also being taken.

Dr. Wood also updated us on an opportunity that she is pursuing with the GEER Grant (Governor's Emergency Education Relief Fund), which will aid in the purchase of technology support. Because there are only a couple dozen grants we have been encouraged to collaborate with other school districts. Dr. Wood mentioned the funds would be used to purchase hot spots.

Dr. Wood took a few moments to thank those who helped with the re-entry plan.
